Sanjay Gandhi Post Graduate Institute of Medical Sciences (SGPGIMS), Lucknow, has been directed by the Govt. of Uttar Pradesh, Medical Education Dept., (vide G.O. I/212108/71-3-2022/ dated 12.09.2022 and vide G.O. I/267779/2023/dated 30.01.2023), to conduct the recruitment examination for the post of Staff nurses, of Self-governing/Autonomous State Medical Colleges (SWA-SHASI RAJYA CHIKITSA MAHAVIDYALAYS in Ayodhya, Basti, Bahraich, Firozabad, Shahjahanpur, Etah, Hardoi, Gazipur, Devaria, Fatehpur, Pratapgarh, Sidharth Nagar, Mirzapur & Jaunpur) of Government of Uttar Pradesh, Department of Medical Education and will be governed by the orders/rules/regulation of the State Government produced from time to time in this regard. The screening/document verification of the eligible candidates after the examination, allocation of medical colleges and issue of appointment letters will be at the level of the Govt. of Uttar Pradesh/ DGME dept. All selections/appointments will be subject to rules/ regulations and conditions of service as laid down by the Govt. of Uttar Pradesh.

Online applications are invited from citizens of India for selection through online written examination for the Post of "Staff Nurse" under Computer Based Examination-2023, whose details of unreserved and reserved category-wise vacancies are given in **Table-01** of the next point.

Important Note:

- If any information provided by the candidate is found to be false at any stage of recruitment process, then the candidature of the candidate shall be summarily rejected.
- 2. No application/fee will be accepted after date as against the above advertisement till the last date of submission of application and fee as per published Examination scheduled on SGPGIMS website. The applicant will not be able to print out his application unless his fee is adjusted by the bank. SGPGIMS does not take any responsibility for adjusting the fees. Candidate can also amend his application form except -Registered Mobile Number, Email, Aadhaar Number, Category, etc. Candidates are advised to visit SGPGIMS website for the detailed schedule of the Examination and application process.
- 3. The language of examination will be both English and Hindi
- 4. The syllabus, question pattern, marking and qualifying marks are as described in the following sections.

- 80% questions will be related to Theory of Nursing knowledge
- 20% questions will be related to Practical application of Nursing work (of these 10% will be related to COVID related work)
- Syllabus will be as per uploaded on the SGPGIMS website
- There will be NO negative marking.
- Language of the examination will be both English and Hindi

Information required for candidates applying online- Online application system is applicable for applying under the above advertisement. The application sent through any other means will not be accepted. Candidates should apply online only. Candidates to apply online Please ensure compliance with the procedure given below.

<u>Process of filling the application form</u> - The process of filling the application form is divided into the five following parts:

Note: The candidate can complete all the above mentioned procedures at once for filling the application form.

Candidates should read the said advertisement carefully and understand very well that they have the desired qualifications for the advertised posts and are covered under the prescribed age limit (21 to 40 years) prescribed for the post. GENERAL CONDITIONS

- 1. Aspiring applicants satisfying eligibility criteria in all respect can submit their ONLINE application only. On-line application (s) will be available on SGPGIMS, Lucknow websites www.sgpgims.org.in
- 2. Applicants must fulfill all essential eligibility criteria, educational qualification, age limit, etc. as per appended Guidelines.
- 3. Amount of non-refundable fee to be paid in respect of one post is as under:-

The candidates belonging to the other category (Horizontal) shall have to pay fee according to their original category.

- 4. On-line Registration and submission process schedule will be published on SGPGIMS website; Examination will be conducted according to the published schedule. Candidates are advised to visit SGPGIMS website for the detail schedule of the Examination.
- 5. As per Acts and GOs on Reservation of Government of Uttar Pradesh may change the number of reserved vacancies in accordance with the prescribed/policy directions in the Ordinances/Orders of the Govt..
- **6.** For recruitment of Staff Nurse for Autonomous State Medical College of Uttar Pradesh, the provisions of "<u>SWA- SHASI RAJYA CHIKITSA MAHAVIDYALAY ADHINASTH NURSING (ARAJPATRIT) SEVA PARINIYAMAVALI-2023"</u> shall apply.
- 7. Before applying, candidates must read the mandatory qualifications (academic) and others prescribed for vacant posts and ensure that they hold the required mandatory

- qualification (educational) and other for the post and only those who are covered under the prescribed age limit can apply online.
- 8. The Uttar Pradesh, Public Services, (Reservation for physically handicapped, dependent of freedom fighters and ex servicemen) Act 1993, dated 29.12.1993, and (Amendment) Act 2018 dated 23.07.2018 &01.09.2018, and (Amendment) Act 2021 vide Notification No. 450 (2/LXXIX-V-1-21-1-ka-12-21 Lucknow dated 10.03.2021 shall apply in the reservation under Horizontalreservation.
- 9. The number of vacancies mentioned in the above Table may increase or decrease as per decision of the Uttar Pradesh State Government.
- 10. Age relaxation for SC/ST& OBC candidates up to a maximum period of 05 years, as per appended guidelines and relevant GOs of Govt of UP.
- 11. In case of Divyang/ Disabled/ Handicapped candidates, the age relaxation is up to maximum period of 15 years (Ref. GO.NO. 18/1/2008-Ka/2/2008 Karmik-anubhag2 dated 03.02.2008 of Government of UP).
- 12. In case of Divyang candidates requiring scribe/writer for taking the examination, the government rules will apply, as per G.O. F. No. 29-6/2019-DD-III/ dated 10.08.2022 & F. No. 34-02/2015-DD-III/ dated 29.08.2018, issued by Govt of Indian , Ministry of Social Justice and Empowerment, Dept of Empowerment of Persons with Disabilities (Divyangjan). The candidates should arrange his/her own scribe/writer. SGPGIMS or Examination body will not be able to provide a scribe/writer for this exam.
- 13. In case of Permanent Government Employees who have rendered not less than 3 years regular and continuous service in the relevant field relax able up to maximum period of 5 years as per appended guidelines and relevant GOs of Government of Uttar Pradesh.
- 14. Relaxation to upper age limit in favor of Ex-serviceman will be as per Govt. of India rules.
- 15. No document including printed/ hard copy of online application forms are required to be sent by post. However, applicants are required to keep one printed / hard copy of their application forms for their records.
- 16. Candidates are required to give their preferences amongst three choice of Cities in which Exams to be conducted (list of cities will be published with the application forms). Exact centre will be given at time of issue of admit card. Effort will be made to allot centre to candidates according to their given preferences. However, in case of non-availability of a slot at their preferred choices, closest other cities will be allotted. Decision of SGPGIMS, Lucknow will be final in this regard.
- 17. Applicants inregular employment must submit a "NO OBJECTION CERTIFICATE" from employers.
- 18. Candidates with valid application shall be issued call letter & admit card. These can be downloaded by candidates directly from SGPGIMS website www.sgpgims.org.in by entering their registration number / application number, Date of birth. Call letters will not be sent by post. This facility would be available on website accordingly as per published scheduled of examination.
- 19. No TA/DA shall be admissible for appearing in writtenexamination etc.
- 20. All Disputes/differences or litigations shall be subject to territorial jurisdiction of Lucknow Court only.
- 21. Medical Education Department, Govt. of U.P. reserves right to fill any or all of advertised posts or not to fill same without assigning any reason. In this regard the Director

SGPGIMS,Lucknow may exercise such rights, as per directions of the Government of Uttar Pradesh.

Age -Limit

- 1- The decisive date of age calculation for recruitment to the post is 1st January, 2023 (in case if Advt is released in between 1st January to 30th June) and 1st July (in case if Advt is released in between 1st July to 31st December). As such on 1st January, 2023, the candidate has attained the age of 21 years and has not attained the age of more than 40 years.
- 2- In case of candidates belonging to Scheduled Castes, Scheduled Tribes, OBCs and other such categories of candidates in Uttar Pradesh, the upper age limit will be as high as specified by the Government.
- 3- In case of Permanent Government Employees who have rendered not less than 3 years regular and continuous service in the relevant field relax able up to maximum period of 5 years as per GOs of Govt of UP, KarmikAnubhag -4 Ref No. -2-E.M./2001-Ka-42013 dated 27.08.2013.
- 4- For appointment on direct entry posts an ex-service man vide U.P.Govt Niyukti (kha) deptt no. 5/1/66-niyukti (kha) dated 16.3.1970, he shall be allowed to deduct the period of his service in the armed forces from his actual age and if the resultant age does not exceed the maximum age limit prescribed for the post / service for which he seek appointment by more than 03 years, he shall be deemed to satisfy the condition regarding the upper age limit. However, he should have rendered satisfactory approved military service in any wing of army, navy or air forces and he should be otherwise eligible for the post.

Reservation-

The Scheduled Tribes/Scheduled Castes/ Other Backward Castes (OBC), EWS & other categories (i.e. horizontal) reservation will be admissible as per the periodic/existing orders of the Government of Uttar Pradesh.

Horizontal reservation:

The Uttar Pradesh, Public Services, (Reservation for physically handicapped, dependent of freedom fighters and ex servicemen) Act 1993, dated 29.12.1993 and(amendment) Act 1997 dated 31.07.1997; and (amendment) Act 2018 dated 23.07.2018 &01.09.2018; and (Amendment) Act 2021 vide Notification No. 450 (2/LXXIX-V-1-21-1-ka-12-21 Lucknow dated 10.03.2021; and UP Govt GO no. 15/5/1986-Ka-2/92 dated 28/04/1992 Karmik Anubhag-2, shall apply in the Horizontal reservation and will be applicable to the identified posts.

Essential Educational Qualification

For recruitment to the vacant posts mentioned in the above Table-1, it is mandatory for the candidate to hold the following mandatory qualifications (educational and other preferential qualifications) as on 1st January, 2023 as per guidelines appended.

Group - B (non-gazetted) & Group - C Posts

Application Form:

Application form is made available online at the SGPGIMSwebsite http://www.sgpgims.org.in as per schedule. Applicants can submit their application online. There is no provision for offline application.

Application Fee: Payable online at the link given at appropriate place.

Schedule of Fee-

For Group B, C posts Rs. 1,000/-

Rs. 600/- for Reserved Candidates

For Group D posts Rs.500/-

Rs. 300/- for Reserved Candidates

(Application Fee is 'Non-refundable')

Age, Qualifications and Experience:

- i) Age for all posts shall be applicable, as notified by the State (UP) Government from time to time.-(Maximum 40 years, Minimum- 21 years)
- **ii)** Age relaxation shall be applicable, as notified by the State (UP) Government from time to time.
- iii) Cutoff date for age, qualifications and experience
 - a) If an advertisement is released between 01st January to 30th June then it will be 1st January of that year.
 - **b)** If an advertisement is released between 01st July to 31st December then it will be 01st July of that year.

Reservation:

Reservation Rules shall be applicable, as notified by the State (UP) Government from time to time. Vide "The U.P. Public services (Reservation for SC,ST and Other Backward Classes) Act, 1994" and "The UP Public Services (Reservation for Economically weaker sections) Act 2020"

Screening:

The candidates are advised to go through the requirements of age, educational qualification, experience, etc. as mentioned in the advertisement and satisfy themselves before applying that they are eligible for the respective post. In anticipation of a huge number of applicants, scrutiny of the eligibility criteria e.g. age, qualifications, experience, etc. will NOT be undertaken at the time of the Common Recruitment Test (CRT). Applications without application fee will be rejected. All applications with application fee shall be accepted provisionally and all candidates will be allowed to appear provisionally in the Common Recruitment Test (CRT).

If any candidate is found not fulfilling the prescribed age, qualification, experience and any other eligibility criteria as per the advertisement, at any stage of the recruitment process, even if the candidate figures in the merit list of the Common Recruitment Test (CRT), his/her candidature will be treated as cancelled without any further notice and the post will be forfeited.

Candidature can also be cancelled at any stage if any information or claim is not substantiated on the scrutiny of the candidates documents by the SGPGIMS/ Govt. of Uttar Pradesh.

Selection Process:

The selection will be done on the basis of the marks obtained in the Common Recruitment Test (CRT) only.

Hall Ticket for the Common Recruitment Test (CRT):

Common Recruitment Test (CRT):

<u>For the post of Staff Nurse</u>, aCommon Recruitment Test (CRT) will be held. The Common Recruitment Test (CRT) will be of **02 hours duration** and will be of **100 marks**. It will contain multiple choice questions (MCQs), as follows –

- 80% questions will be related to Theory of Nursing knowledge
- 20% questions will be related to Practical application of Nursing work (of these 10% will be related to COVID related work)
- Syllabus will be as per uploaded on the SGPGIMS website
- There will be NO negative marking.
- Language of the examination will be both English and Hindi

Minimum qualifying marks of the Common Recruitment Test (CRT) for the post will be:-

40% for - General& EWS.

35% for - SC,ST & OBC

Final Merit List:

The final merit list will be prepared ONLY based on the marks obtained in the Common Recruitment Test (CRT), for all categories (i.e. GENERAL, OBC, SC, ST, EWS, etc) separately and rank will be awarded to all qualified applicants. While preparing the selection list for the General category, all applicants (including those from the reserved categories) will be taken into consideration, but while preparing the selection list for a reserved category, **only** applicants of that category will be taken into consideration. The same method will be applicable in all reserved categories.

Resolution of Tie: In cases where more than one candidate secures equal marks, the tie will be resolved (i) First by using the date of birth, with older candidate placed higher (ii) If not resolved by the date of birth, it will be resolved by the number of wrong answers/ negative marks, those with less wrong answers/ negative marks placed higher.

Results:

All results will be declared in due course, as early as possible.

Canvassing in any form will be a disqualification.

Other observations-

- 1. Working experience in Government/ semi government organization wherever applicable will include experience either on regular post or outsourced/contractual, with accompanying evidence-based certificate. Applicant will submit an affidavit that experience mentioned in the certificate is true and SGPGIMS/ Govt. of U.P. may verify the facts from the concerned Institution/ Party.
- 2. For posts having experience as an Essential Criteria, the experience which has been acquired only after obtaining essential qualification will be considered as valid.

3. Any dispute with regard to any matter referred herein shall be subject to the jurisdiction of Lucknow court alone.

Note:

- 1. The Notification of "The Uttar Pradesh Direct Recruitment to Junior Level Posts (Discontinuation of interview) Rules 2017" Notification Miscellaneous No. 4/2017/1/1/2017-Ka-2 Dated 31 August 2017, the earlier provisions/guidelines in respect of recruitment of group 'B' (Non Gazetted), group 'C' and group 'D' are superseded by this rule 2017 and recommended to adopt these Rules for recruitment of group 'B' (Non Gazetted), group 'C' and group 'D' posts of U.P. Govt. institutions/ colleges including SGPGIMS.
